## Custom Sign Company Membership

NSSA is an Affiliated Association of the International Sign Association (ISA) and represents custom sign companies in the northeast region of the United States including Connecticut, Delaware, Eastern Pennsylvania, Greater Washington D.C., Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Rhode Island and Vermont. Custom Sign Companies who join NSSA become automatic members of ISA and share in the benefits of both organizations.

Product manufacturers and representatives, suppliers, distributors, sign support service companies, sign end-users and sign associations may join NSSA directly.

### Classes of Membership

**Custom Sign Company** - Any individual, partnership or corporation engaged in the retail sale, lease, design, manufacturing, production, installation and/or maintenance of signs.

**National Sign Company** – A sign company engaged in the sale or lease of signs and/or related services that operates in a multi-state or national market area. National sign companies must join ISA directly to receive ISA benefits.

**Product Manufacturer/Supplier** - Any individual, partnership or corporation engaged in the manufacturing of a material, product or products used in the design, manufacturing, production and/or installation of signs.

**Distributor** - Any individual, partnership or corporation engaged in the warehousing, sale and distribution of a range of products to the sign industry; such products need not necessarily be manufactured by said distributor.

**Satellite Office** – Any additional office of a national sign company, product manufacturer, supplier or distributor located in additional states. Required for additional web listing.

**Manufacturer Representative** - Any individual representing one or more product manufacturers and whose interest is in promoting the sale of products made by those manufacturers to the sign industry.

**Support Service** - Any individual, partnership or corporation which offers a service to the sign industry, such as consultants, brokers, architectural/design, advertising agencies, permit service firms, insurance agents, and publishing companies engaged in the publication of magazines and reference material to the sign industry.

**Sign End User** - Any individual, partnership or corporation which purchases and uses signs in the course of business

**Sign Association** - A not-for-profit sign industry association located in the United States or Canada.
